SNAI S.p.A. e SNAI Servizi S.r.l. hanno avuto notizia di una missiva da parte di Bridgepoint Capital Limited nella quale Bridgepoint richiede danni per un ammontare di Eur20milioni a seguito della mancata accettazione di una offerta relativa all'acquisito del ramo scommesse della SNAI S.p.A. presentata da Bridgepoint.

SNAI S.p.A. e SNAI Servizi S.r.l. ritengono che tale richiesta sia totalmente infondata e contesteranno vigorosamente la stessa qualora Bridgepoint decidesse di procedere ad azioni legali a tal riguardo. Nel contempo, SNAI S.p.A. e SNAI Servizi S.r.l. hanno conferito mandato ai propri legali di tutelare gli interessi delle stesse nelle più appropriate sedi al fine di ottenere il risarcimento dei danni causati da tale iniziativa.

Joint press release SNAI S.p.A. and SNAI Servizi: Bridgepoint requests are groundless

SNAI S.p.A. and SNAI Servizi S.r.l. received a letter from Bridgepoint Capital Limited claiming damages of Eur20million arising from the non acceptance of an offer made by Bridgepoint for the gaming and betting activities of SNAI S.p.A..

SNAI S.p.A. and SNAI Servizi S.r.l. believe that the request is totally groundless and will contest vigorously should Bridgepoint decide to take formal legal action based on the claims raised in such letter. SNAI S.p.A. and SNAI Servizi S.r.l. have also instructed their legal counsels to pursue all actions necessary to protect their interests in relation thereto and to seek recovery for any damages caused by this initiative.
